The flexible seating includes high tables with stools or students can stand at the table, rocking chairs, beach chairs, bouncy balls among others. The students get to choose what kind of seat they want to sit in. McCarthy stated the seats are comfortable, help with collaboration and sensory input and are just fun. She also stated you must have good classroom management skills to be able to do this in your classroom. She has had the flexible seating now for 8 years.
