Janelle Sulhoff, Elementary Instructional Coach spoke about the intervention system at the elementary. She stated K-5 students are screened 3 times per year and it is determined if they are proficient or not proficient. If they are not proficient then they are put into an intervention which they go to 4 times per week for 40 minutes. The intervention group is based on skill needs and they can be put into different intervention groups if need be. Janelle stated she meets with the teachers 1 day per week to progress monitor and see how the students are doing. This is the third year the elementary has been using this system.

Engel moved to approve the request to the School Budget Review committee for Modified Supplemental Amount and Supplemental Aid for the 2021-2022 Dropout Prevention Program in the amount of \$150,253 for expenditures necessary to implement the 2021-2022 at risk and dropout prevention program.
