On the last day they got to build a fire and roast hot dogs and marshmallows. The School of the Wild would not be possible if it wasn't for the businesses and parents who donate money and food.

Business Manager Sue Rich presented the official certified annual report for the 2022-23 school year. This is the comprehensive financial report of the school district for the year ending June 30, 2023. Total general fund revenues for the year were \$8,051,071. with 49% local sources (property taxes); 47% state sources and 4% federal sources. Total general fund expenditures were \$7,981,434 with 70% salaries & benefits; 26% purchased services, supplies, equipment and 4% AEA pass-thru and transfers. Our estimated spending authority is \$3,434,009.

Longbine made a motion to accept the Certified Annual Report for fiscal year 2023. Seconded by Ruth.

Motion carried 4-0

Business Manager Sue Rich then presented the special education supplement for the 2022-23 school year. The total revenues were \$1,194,133 and the total expenditures were \$1,572,971. This resulted in a negative special education balance of \$378,838 which can be recovered through allowable growth and supplemental aid from the state.

Ruth made a motion to accept the Special Education Supplement for fiscal year 2023. Seconded by Jepson.

Motion carried 4-0

Longbine made a motion requesting modified allowable growth and supplemental aid for a negative special education balance in the amount of \$378,837.64. Seconded by Jepson.

Motion carried 4-0

Business Manager, Sue Rich then presented the Transportation Report for the 2022-23 school year. Total net transportation costs were \$361,383 with an average cost per mile traveled of \$5.11. The average cost per pupil transported was \$945.30.

Ruth made a motion to accept the Transportation Report for fiscal year 2023. Seconded by Longbine.

Jepson made a motion to approve the supplemental amount for excess LEP costs for serving ELL students in a limited English Instructional Program during the 2022-23 school year in the amount of \$45,466.30. Seconded by Longbine.

Ruth made a motion to approve the 3 students for early graduation pending all requirements are met. Seconded by Longbine.

Motion carried 4-0

Ruth made a motion to approve the National Honor Society Chapter Bylaws. Seconded by Jepson.

Longbine made a motion to approve OPN Architects Pre-Bond Services contract in the amount of \$9,000. Seconded by Jepson.
